A representative, Joe Kasin, from the Suffolk County Fire Marshall's Office shared a report about the results of the District's fire inspection.

Mrs. Friefelder gave the second budget presentation for the 2014-15 school year. Mrs. Friefelder explained where revenues came from – federal aid, state aid, fund balance, reserves and grants. The bulk of money comes from the tax levy. Starting in 2008-09, there was a tremendous decrease in state aid because New York State had a large budget deficit. A lot of money was taken away from the school districts which is called the gap elimination aid adjustment. In 2012 the state started to restore some of that money but not a lot and we have not been receiving the amount promised to us. This year they have promised \$21,968,651. There are no guarantees that we will receive that much. (*See attachment #1*.)
