- **B.** Superintendent of Schools Dr. Kelly Pre-k update informational meeting regarding pre k program. 50 parents were present and 10 parents signed up their children. We are doing a mailing to raise more interest in the program. Dr. Kelly gave parents an update on traffic concerns at northwest - contacted Dpt. Public works and Police Dpt. and were able to get "No U Turn" signs put in front of NW and Dr. Martin sent home back pack letters to emphasize importance of safety upon arrival at NW and dismissal. We now have a crossing guard at Smith St. Trustee Santos suggested asking staff to park in the back or on the side. Dr. Kelly will look into it as a possible solution. Some members of our community and staff have received awards from SCOPE Educational Service - Mr. Nathan King, Mrs. Sanji Crawford, Clark, Mrs. Marianne Niblock, Mr. Robert Claps and Dr. Pauline Collins. Three members have received NYSSBA awards for Board mastery and leadership development  $-1^{st}$  Vice President Nathan King, Trustee Dr. Kathleen Corbett and Trustee Mark Epps. 1<sup>st</sup> Vice President King is the recipient of another NYSSBA award for school board service - School Board Member of the week. The Science class of Mrs. Marion Weber will be highlighted in a video being produced by Kiwanis International Association thanks to Trustee Dr. Corbett who wrote and won a grant "Marine Biology Comes Alive. The Kiwanis International has funded a fishing trip for the group. Trustee Dr. Corbett has been invited to participate in a two day school counselor's summit in Albany this summer. She will serve as an expert panelist. We are looking at a weekend in May to hold a memorial planting and ceremony to honor Dr. Williams. Hopefully his family will be able to attend.

**C.** <u>Board of Education</u> – Vice President King attended a conference in Albany and spoke to Joe Saladino and Robert Sweeney who are working for our district. He also spoke to John Flanagan who is the Chair of the Senate Education Committee. The governor is proposing to increase building aid by \$381,000. But, we also heard that the legislature was going to propose a 40% cut in building aid for the 2014-15 school year. They are also proposing aid for security to make sure that the schools are safe. Also, if we have to make decisions on human rights we must make sure that they correlate with Human Rights Laws.</u>

Trustee Santos attended a play at the Middle School. They made a presentation to the Basketball Team which is undefeated.

Dr. Kelly responded that the Board is in receipt of your letter. We need to honor and recognize the students. I spoke to Dr. DeRose about putting some plans in place to honor them. Mr. Steffanetta said that we appealed the forfeiture of the Feb. 22 playoff game. We presented a written argument and the appeals committee denied the District's appeal. We filed a second appeal and that was denied also. There are very strict rules regarding a school using an ineligible

player. Will speak to the Board on any further action they may want to take.

Susan Heenan, 2 Matthew Dr. Amityville – Mrs. Heenan requested an update on the committee on bullying.

Dr. Kelly said that the committee has been looking into different programs. At our next meeting we will discuss what programs we want to adopt.

Shawn Williams, Amityville – Mr. Williams spoke about showcases for the basketball team. Dr. Kelly said that no decision has been reached. She will speak to Mr. Agostino about how they can they be showcased in order to have scouting opportunities. He will get back to me.
