**BUDGET PRESENTATION #6**

Mrs. Friefelder said that tonight is the third component of the budget( program/instructional). We have not addressed the staffing projections in this part of the budget. (See attachment #1 for line by line budget). No salary increase in the teachers lines. We are still negotiating their contract. Parents can send their children to a charter school and we must pay a contractual rate set by the NYS Ed. Dpt. Parents do not have to notify us if they are going to send their child to a charter school. I believe that we should be notified by April 1 so that we can budget for it. If the District decides not to pay it, the state will take it out of the school aid for the District. All of our transportation providers have agreed to renew our contracts for next year at 3%. Otherwise we would have had to go out to bid, and the cost would have been significantly more.
