

replace the boiler tubes in three buildings. The boiler tubes in the other two buildings will be replaced in the future. Jack Dzedzic will address the Board regarding this issue. Three portable classrooms at the high school have been renovated. Every blind and every shade in the district is now working. Middle School stairway railings have been repaired. Park Avenue got a brand new playground through donations and fund raising. The insurance company checked all playground equipment – still waiting for report. A master locking system will be integrated hopefully within the next month. Clock system is still an issue and renovation of the fields is still on the list. Boys' & girls' lockers have been replaced at the Middle School. Drapes in the Middle School auditorium have been replaced. The high school has a new electronic sign. A lot of purchases were made for custodial supplies and equipment and an inventory has been completed. Equipment has been evaluated and over time will be replaced. Northwest roof and Northeast roof were repaired. A District wide issue is ADA Compliance. It is not completely resolved. Some curb cuts have been put in for wheelchairs. Each curb cut cost \$35,000. It is being addressed at all buildings. Solar panels have been installed at the high school and we look forward to savings over the next year when it is complete. Grant money has been provided for it, \$250,000, by Senator Fuschillo. All lighting will be replaced in classrooms and hallways with more energy efficient lighting and will be completed during the summer. The next issue is space and that is what is being evaluated – short and long term goals for all buildings. Custodial, grounds and maintenance crews, if trained appropriately, should be able to do more in house projects which would eliminate going to outside contractors. Considerations for the District and all buildings were then discussed. See attachment #1 for details.

The Board applauded Mrs. Freifelder for her thorough report and the work she had done.
